The past year has been a busy one for the MMLA. We realized a long-standing goal to solidify the status of the end of South Shore Road that will help avoid extensive development in that area. We reached a resolution in an MMLA sponsored court case that affects future development of the Owls Head area, and we continued support for our regular programs that help insure that Merrymeeting Lake remains one of the most pristine and beautiful lakes in New England.

- Negotiated deed restrictions on several lots at the end of South Shore Road (see accompanying article in this newsletter)
- Concluded Owls Head court case (related article later in this newsletter)
- Continued funding, organization, and management of the NH Lake Host program, supplying hosts who greet boats visiting Merrymeeting Lake, educate the owners on invasive weeds and other threats to our water quality, and inspect the boats coming in and out of the lake
- Sponsored the Merrymeeting Lake Water Quality program, a program that actively monitors and tests the quality and clarity of Merrymeeting Lake water on a weekly basis.
- Management of the Watershed Conservation Fund used to help preserve the lands and watershed surrounding Merrymeeting Lake
- Funding of the popular LakeCam and the MMLA website, www.mmlake.org
- Organization of late-spring, roadside, cleanup effort.
- Organization of social activities such as the upcoming Block Party and the July fireworks show.
- Publication of this annual newsletter and other news of interest to lake residents via the website, email, and periodic postal mailings

MMLA Water Quality

At least once a week during the spring, summer, and fall, a small group of volunteers quietly cruises the lake in the early morning, performing one of the most important activities supported by the MMLA, water quality monitoring and testing of Merrymeeting Lake. Your membership and donations allow this work to continue.



In cooperation with the UNH Cooperative Extension service, water quality samples are taken at several key spots around the lake. The team tests for water temperatures at multiple depths, measures water clarity in both sunlight and shade, takes various chemical measurements (pH, conductivity, etc.), and collects both surface and depth water samples that are sent to the UNH lab for further analysis.

The good news is that testing shows that Merrymeeting Lake continues to be one of the most pristine lakes in the Northeast. The MMLA volunteers have been doing this for more than 30 years, and the results are consistently positive. However, as seen with other lakes, things can change quickly. The ongoing monitoring, supported by the MMLA and your extra donations to the Water Quality Fund, will allow us to identify developing problems early, and hopefully implement changes to correct the problems.

Annual reports are available for almost every year over the past 30. They are available upon request. The most recent ones can be obtained via the MMLA website, www.mmlake.org.



What Can You Do to *protect loons*

Through the generosity of a donor who wishes to remain anonymous, the MMLA has received a \$12,000 donation to fund the protection and preservation of loons on Merrymeeting Lake.

Loons are a very visible and anticipated indicator of the health of our lake and watershed. This donation will help the lake association guard land and water areas that the loons use for nesting and feeding, along with supporting the water quality testing that helps preserve and protect the loon population on Merrymeeting lake.

What Can You Do to Protect Loons? Why do some lakes have loons and not others? Loons need healthy aquatic ecosystems with good water quality, abundant prey, irregular shaped shorelines or islands with native vegetation, and nursery habitat with little to no human disturbance. Therefore loons are considered to be an indicator species, meaning that the presence of a loon may indicate that a lake that they live on or frequently visit is healthy.

Practice Good Loon Etiquette

- Watch loons from a safe distance and never explore a loon nest site. Close encounters can be deadly for swimming and nesting loons.
- Be an ethical angler. Never fish or cast near loon nests or swimming loons, properly dispose of extra bait and trash, and pick up monofilament line.
- Keep dogs and cats away from loons and nests. Pets disturb nesting loons and can destroy loon eggs.
- Be a responsible boater. Never chase loons or run motorboats or personal watercraft over areas where loons have been seen. Loons and loon chicks have died from being hit by boats and propellers.
- increases aquatic plant growth, making it difficult for loons to swim and find food.
- Protect loons from your pets. Keep dogs and cats away from loons and nests. Pets disturb nesting loons and can destroy loon eggs. And please clean up your pet's waste - pet waste can also contribute unwanted nutrients and bacteria to the water.
- Loons need good water quality, healthy lake habitats and ecosystems to survive and thrive. Local government agencies do not have the capacity or resources to monitor the water quality on all lakes; therefore, volunteer monitoring is a vital component to determining the water quality of our lake.

Protect and Restore Loon Habitat

- Protect native vegetation. Loons nest on natural shorelines and use natural materials to build their nests this also protects water quality by slowing and absorbing runoff materials from entering the lake.
- Use only phosphorus-free fertilizers on shorelands, and only if needed. Fertilizer that runs off into lakes
- Make sure your septic system is functioning properly. When septic systems don't work properly, they pose serious risks to human, animal and environmental health by releasing contaminants, including harmful bacteria and chemical pollutants, into the groundwater and into surface water - lakes, rivers, marshes and streams.

Lake Host Program

Gearing Up for 13th Season on Merrymeeting Lake



This past winter the NH Lakes Association received a 2015 Outstanding Invasive Species Volunteer Award at the National Invasive Species Achievement Awards Ceremony held in Washington D.C. The NH Lakes Association was recognized for the 500 Lake Hosts who volunteered 11,093 hours on NH waterbodies in 2014.

We want to take this opportunity to thank our local volunteers here at Merrymeeting Lake who contributed to that total! A special thank you to Dr. Fred Quimby who has volunteered a morning a week at the ramp for the past 6 years! Thank you Fred!

The Lake Host Program continues to be an essential line of defense in protecting Merrymeeting Lake from invasive plants and animals. Paid and volunteer Lake Hosts provide courtesy boat inspections at the public launch (the dam) throughout the summer boating season. They have “caught” milfoil and other aquatic plants a number of times - removing the plants before the boat was launched - each time protecting Merrymeeting from a potential infestation of invasive plants.

Lake hosts are not only looking for milfoil and other invasive aquatic plants and animals, but they are also educating boaters about the many invasive species that threaten Merrymeeting and other lakes all over the State. The Lake Hosts teach boaters how to prevent the spread of these invasive plants and animals by cleaning, draining and drying their boats and trailers after leaving a lake or river. Please be sure to follow the clean, drain and dry protocol if you travel with your boat to other lakes, and please make sure any guests you may have who launch their boat on Merrymeeting follow the protocol too. Owls Head Update

In 2012, a development proposal for a large piece of land on Owls Head Ridge was brought before the New Durham Planning Board by the land owner.

The proposal was of concern to the MMLA as it proposed a much higher density of development in our watershed area than previously seen using duplex home designs. There were many questions concerning whether the proposal met existing bylaws and deed restrictions.

Several abutters with similar deed restrictions banded together to challenge the proposal through a lawsuit, based on their contention that the affected lots also had these deed restrictions and these deed restrictions should prohibit the proposed development. But the anticipated legal fees were beyond their ability or willingness to proceed.

With encouragement and financial support from the MMLA, the group proceeded with the lawsuit. While the case was proceeding through the court system, the largest acreage piece of affected property was acquired by a new owner. This new owner has no current development plans, and has a history of supporting conservation and water quality efforts on Merrymeeting.

In July of 2014, the Strafford County Superior Court issued its decision in the case after a trial concerning the remaining parcels. The Court did enforce the single-family home deed restriction to prevent development of any multi-family homes on any of the contested parcels. As a result, a primary goal of the litigation was successful. The support provided by the MMLA helped to insure continued maintenance of the quality of the watershed and the desired density of homes in the area.”

Meeting House relocated and ready

The Merrymeeting Lake Association Meeting House 2.0 will be open for the Annual Meeting on Saturday June 27th at the corner of Merrymeeting and Powder Mill roads. Just a short move to a new foundation plus a bathroom and parking puts new life into a once deteriorating and virtually abandoned building. This move insures that the MMLA Meetinghouse will be here for future generations by granting the lake association permanently deeded rights to use the building, without costly maintenance. Although the Meetinghouse looks different on the outside it has retained its original look and character on the inside. Come to the annual meeting and check it out for yourself.

Old MMLA Meeting House Foundation removal planned

The Lake association is working with Fish and Game to removal of the old Meetinghouse foundation. The property owner must get a shoreline permit in order for the contractor to work next to the water. We hope this will be completed shortly.

What's Happening on Birch Ridge/Red Oak Ridge?

It would have been difficult to not notice the tree cutting going on above the lake last summer and fall. The noise of the cutting machines and falling trees was hard to miss. We received many inquires about the activity, with many wondering what could be done to stop it.

The MMLA continues to actively monitor the status of the Birch Ridge properties. The property are still owned by a large, out-of-state, real estate investment firm. Last year they contracted with a well-respected, New Hampshire forestry service to harvest lumber from the properties. This is perfectly legal for any landowner in NH, and all indications are that good forestry practices, as defined by the UNH Cooperative Extension, were followed. Many healthy trees were left in place, disturbance of ground cover was kept to a minimum, and to date we have seen no change in the water quality below the ridge. Done correctly, the forest can actually become healthier over time if these good practices are followed.

While we do not know what is now planned for these properties, we continue to monitor for any activity that will indicate a change in status, and we hope someday to resume discussions on the possibility of setting aside the land in conservation.

Success on South Shore

Merrymeeting Lake Association members may recall that the MMLA has held an option for a right of first refusal on the property at the far end of South Shore Road (#400) since 1979. The intent of this option was to ensure that the property could never be used as an access point to the lake from Birch Ridge, Lions Camp Pride, or any other abutting land. It would also prevent connection of a road all the way around the lake to Kings Highway. Thanks to the foresight and perseverance of the association's leadership over a 35-year period and the vision and excision of this right of refusal by the late Donald Bryant esq. the property was within our ability to control. The property was recently sold and the right of first refusal was converted to a permanent deed restriction that will never allow the property to be an extension of South Shore road or access other properties. This is a huge achievement for the MMLA and its Watershed Conservation Program and an important impediment to any future development by Red Oak Ridge or others. The MMLA would like to welcome new neighbors Bruce and Cathy Long to Merrymeeting Lake and thank them for their support and gracious acceptance of the permanent deed restrictions. Bruce and Cathy are new to the lake but have helped the lake and the cause of the MMLA in a great way!

Water Monkey Camp gets approval

At last year's MMLA annual meeting the attendees voted overwhelmingly to support the camp, and this year the Town agreed. New Durham planning board voted 5-0, and the ZBA 4-1, to approve the operation of Water Monkey camp at the Cove Cottage property. The camps founder, Evan Goldner, expects the camp will begin seasonal operations this June. The camp is limited to just 21 campers and 9 staffers. Boats will only ski on Weekdays in order reduce the potential for weekend boating congestion also the camp is restricted from the use of jetskis and personal water craft of any type. The camp has also volunteered the use of the property for the MMLA Annual Block Party on Saturday July 11th.
